SALIENT POINTS OF THE PROGRAMME

1. ROTP Programme will be of 6 Days duration.
2. Any Teacher of an Ayurvedic college can apply in the prescribed proforma to participate in the CME Programme.
3. Application form must be sent by the applicant through proper channel forwarded by competent authority.
4. On selection, applicant will be sent an invitation letter by **E-MAIL** from Organizing Secretary of the CME Programme. In response to that invitation, applicant has to send a consent letter to confirm his/her participation, failing which it will be assumed that the applicant is not willing to participate and his/her candidature will be cancelled.
5. Participants selected for the CME programme will be reimbursed with Rail fare (up to 2nd A.C./)/ Actual fare (not exceeding rail fare up to 2nd A.C.) on production of original tickets of the onward journey and photocopy of return journey by the shortest route.
6. Participants will be provided with boarding and lodging expenses as per guidelines of CRI, Jaipur and they will have to arrange boarding and lodging facilities on their own.
7. Last date of form submission is 12th February 2010. Applications received after this date will not be considered.
