- The eligibility criteria for Upgradation and Promotion under DACP is a Medical Degree and Research Publications as mentioned in the RRs. It is submitted for kind information of DPC that all the Teachers of the Institute possess Post-Graduate Degree in Ayurveda in their respective Disciplines and many of them have Ph.D.(Ayurveda) Degree also.
- All the Teachers who are eligible for Promotion in the present DPC Meeting, have the required Number of Years of Regular Service and also more than the required Number of Research Publications to their credit, i.e. 3 for Professor, 1 for Associate Professor and 2 for Assistant Professor.



- Therefore, they fulfill all the criteria required and are, therefore, eligible to be considered for Up-gradation and Promotion under DACP Scheme.

It has now been decided to extend the said DACP Scheme up to the SAG level in the Pay Band (PB-4) to the teaching staff of Ayurveda, Unani, Siddha and Homeopathy Doctors working in the National Institutes of Ayurveda, Unani, Siddha and Homoeopathy respectively w.e.f 1<sup>st</sup> April, 2015.

2. The number of years of regular service required for up-gradation to various grades upto SAG level under the DACP Scheme will be in accordance with the recommendation of the Expert Committee on the conditional concurrence given by DoE and approved by IFD, is as follows :-

3. All medical doctors (Ayurvedic, Unani, Siddha and Homoeopathy) in the Teaching cadre whether belonging to organized services or holding isolated posts, will be covered by the DACP Scheme. Essential qualification prescribed for the posts falling in purview of DACP Scheme shall be at least – Medical Degree in Ayurveda/Unani/Siddha/Homoeopathy System of medicine or MBBS/MD or their equivalent. As such criteria for eligibility in DACP shall be a medical degree possessed by the incumbent, Research publications etc., as per requirement of RRs amended from time to time. Tenure posts, posts filled on short term contract and deputation are excluded from the purview of the DACP Scheme. Further officers not having medical qualification are not eligible for promotion under DACP Scheme.

4. The above orders shall apply w.e.f 1<sup>st</sup> April 2015. The total financial implication involved in the matter shall be intimated to the Ministry. The same will be met from the funds of the respective Institutes.

5. The above mentioned promotion under DACP Scheme will be made by the respective National Institute without linkage to vacancies.



**Subject:** Extension of Dynamic Assured Career Progression (DACP) Scheme in respect of AYUSH Doctors working in National Institutions (NIA/NIS/NIH/NIUM)-reg.

In supersession of this Ministry's OM of even No. dated 3/11/2014, the undersigned is directed to say that conditional concurrence given by Department of Expenditure (DoE) regarding grant of DACP benefits has been reviewed by Expert Committee constituted in this regard, in consultation with Integrated Finance Division (IFD)/DoE, MoF. It has now been decided to extend the said DACP Scheme up to the SAG level in the Pay Band (PB-4) to the teaching staff of Ayurveda, Unani, Siddha and Homeopathy Doctors working in the National Institutes of Ayurveda, Unani, Siddha and Homoeopathy respectively w.e.f 1<sup>st</sup> April, 2015.

2. The number of years of regular service required for up-gradation to various grades upto SAG level under the DACP Scheme will be in accordance with the recommendation of the Expert Committee on the conditional concurrence given by DoE and approved by IFD, is as follows :-

3. All medical doctors (Ayurvedic, Unani, Siddha and Homoeopathy) in the Teaching cadre whether belonging to organized services or holding isolated posts, will be covered by the DACP Scheme. Essential qualification prescribed for the posts falling in purview of DACP Scheme shall be at least – Medical Degree in Ayurveda/Unani/Siddha/Homoeopathy System of medicine or MBBS/MD or their equivalent. As such criteria for eligibility for DACP shall be a medical degree possessed by the incumbent, Research publications etc. as per requirement of RRs amended from time to time. Tenure posts, posts filled on short term contract and deputation are excluded from the purview of the DACP Scheme. Further officers not having medical qualification are not eligible for promotion under DACP Scheme.

4. The above orders shall apply w.e.f 1<sup>st</sup> April 2015. The total financial implication involved in the matter shall be intimated to the Ministry. The same will be met from the funds of the respective Institutes.

5. The above mentioned promotion under DACP Scheme will be made by the respective National Institute without linkage to vacancies.

6. Each individual order shall have 'recovery' clause in case of any amendment to the order or further order in this respect or any overpayment.

7. This issues with the approval of Ministry of Finance, Department of Expenditure vide ID No. 300286500/E-III (A)/2016 dated 25<sup>th</sup> April, 2016 and further approval of AS&FA vide FTS No. 3101385 dated 30<sup>th</sup> May, 2017 and IFD concurrence Dy. No. C-703 dated 31<sup>st</sup> May, 2017.

**OFFICE MEMORANDUM**

**Subject: Extension of Dynamic Assured Career Progression (DACP) Scheme in respect of AYUSH Doctors working in National Institutions (NIA/NIS/NIH/NIUM)-reg.**

Ministry of Health and Family Welfare vide its OM No. 45012/2/2008-CHS.V dated 21/7/2009 has issued certain clarifications regarding initial implementation of DACP Scheme.

2. Pursuant to the above and in continuation to the Ministry's OM of even No. dated 6/6/2017 and 27/6/2017, it is clarified that it was not the intention to straightaway grant Senior Administrative Grade (Grade Pay of Rs. 10,000 in PB-4) to an individual on mere completion of 22 years of service. In fact, for being eligible for upgradation under DACP Scheme, a doctor has to render minimum qualifying service in the immediate lower grade as prescribed in the OM dated 6/6/2017 and 27/6/2017. Therefore, the question of direct promotion under DACP Scheme to the Senior Administrative Grade from Grade Pays of Rs.5400/-, 6600/- and 7600/- does not arise.

3. It has, therefore, been decided that at the time of initial implementation of the Scheme (i.e. w.e.f. 01.04.2015), depending on the length of Service rendered by a Doctor (Teaching and Non Teaching), he/she can be directly placed in the grade corresponding to his length of services prescribed by the letter dated 6/6/2017 and 27/6/2017 subject to the condition that such placement will be done only upto NPSG Scale i.e. Grade Pay of Rs.8700/- in the Pay Band-4.

4. To illustrate, at the time of initial implementation of DACP Scheme for doctors working in isolated Post/Cadres the following methodology may be adopted:

(a) A Doctor with less than 15 but more than 10 years of service whether in the Grade Pay of Rs.5400 in the Pay Band-3, or in the Grade Pay of Rs.6600 in the Pay Band-3 can be directly placed in the revised pay structure of Grade Pay of Rs.7600 in the Pay Band-3.

(b) A Medical Doctor with more than 15 years of service whether in the Grade Pay of Rs.5400 in the Pay Band-3, or in the Grade Pay of Rs.6600 in the Pay Band-3, or in the Grade Pay of Rs.7600 in the Pay Band-3 can be directly placed in the NPSG Pay structure of Grade Pay of Rs.8700 in the Pay Band-4.

(c) A Doctor with more than 22 years of regular service and already regularly promoted in the Grade Pay of Rs.8700 in the Pay Band-4 on the date of initial

implementation of the Scheme can be granted SACI pay structure of Grade Pay of Rs.10000 in the Pay Band-4 without rendering full 7 years of service in the NFSG grade

5. Similarly in case of Doctors working in isolated posts cadres who are appointed directly in the Grade Pay of Rs. 6600 in PB-3 DACP may be implemented in the following manner :-

(a) A Doctor with more than 10 years service whether in the Grade pay of Rs.6600 in the Pay Band -3; or in the Grade pay of Rs.7600 in the Pay Band- 3 can be directly placed in the revised pay structure of grade pay of Rs. 8700 in the Pay Band -4

(b) A Doctor with more than 17 years of regular service and already regularly promoted in the Grade Pay of Rs.8700 in the Pay Band-4 on the date of initial implementation of the Scheme can be granted SACI pay structure of Grade Pay of Rs.10000 in the Pay Band-4 without rendering full 7 years of service in the NFSG grade

6. Having been granted financial upgradation under DACP in above manner at the time of initial implementation of the Scheme; thereafter, the Doctors would have to earn their next upgradation under DACP Scheme as per the eligibility of service prescribed in the OM of even number dated 6/6/2017 and 22/6/2017.

7. This issues with the approval of IFD vide FTS No. 105288 dated 9/8/2017 from the O/o SS&FA, MoHFW.
