1. Jai Prakash Sharma S/o Shri Chaju Lal Sharma, Age 51 Year working as Deputy Director (Admn.) in the National Institute of Ayurveda, Madhav Vilas, Amer Road, Jaipur do hereby submit an undertaking on behalf of National Institute of Ayurveda, Jaipur as under :-

1. That the National Institute of Ayurveda, Jaipur shall not offer any programme(s) in the distance mode after its declaration as a Deemed to be University.
2. That the National Institute of Ayurveda, Jaipur is a not-for-profit organization and shall not be engaged in commercialization of higher education.
3. That the National Institute of Ayurveda, Jaipur has not violated any of the provisions of any of the statutes/guidelines of any Statutory Authority in the period of five years preceding the date of submission of the application seeking status of an National Institute of Ayurveda, Jaipur Deemed to be University.
4. That hostel accommodation shall be gradually increased to at least 25 % of the students within 3 years of existence of institution Deemed to be University.
5. We undertake to submit undertaking from the funding agency is Ministry of AYUSH, Govt. of India to the effect that on being declared as National Institute of Ayurveda, Jaipur deemed to be university, the National Institute of Ayurveda, Jaipur shall continue to receive the funds for maintenance and developmental expenditure, including the salary and non-salary increases in expenditure and the future expansion.

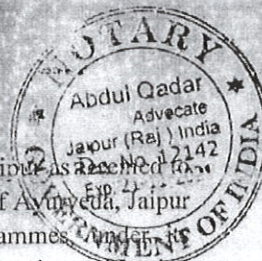

That on being declared National Institute of Ayurveda, Jaipur as Deemed to be University under the UGC Act, the National Institute of Ayurveda, Jaipur shall admit students to its approved academic programmes under its enrolment, only from the academic session subsequent to the notification issued by the Central Government and enrolment of students to the National Institute of Ayurveda, Jaipur for any reason whatsoever, in anticipation of the declaration as an National Institute of Ayurveda, Jaipur Deemed to be University or inclusion of the National Institute of Ayurveda, Jaipur under the ambit of an National Institute of Ayurveda, Jaipur Deemed to be University, shall render the application invalid.
7. That the income and property of the National Institute of Ayurveda, Jaipur, howsoever derived, shall be utilized only for the promotion of the objectives of the National Institute of Ayurveda, Jaipur including its growth and development. No portion of the income/ property of the National Institute of Ayurveda, Jaipur shall be paid or transferred, directly or indirectly be way of profit, to the persons who were / are members of the National Institute of Ayurveda, Jaipur provided that nothing herein contained shall prevent the payment in good faith or remuneration to any member thereof or to any other person in return for any service rendered to the National Institute of Ayurveda, Jaipur or for travelling, halting and other similar charges, and all such expenditure shall be appropriately reflected in the accounts of the National Institute of Ayurveda, Jaipur, maintained for the purpose.
8. That the professional programmes already being conducted by it, if any, have the approval of the relevant Statutory/Regulatory body like CCIM along with a duly attested copy of the letter of approval granted to it by such body. In addition, each application shall be accompanied by an essentiality certificate from the State Government concerned, wherever necessary.
9. That after declaration of the National Institute of Ayurveda, Jaipur as Deemed to be University, it shall not use the word 'University' suffixed to its name but may mention the words "Deemed to be University" within parenthesis suffixed thereto.
10. That the land and other assets of the National Institute of Ayurveda, Jaipur shall rest with the Deemed to be University i.e. National Institute of Ayurveda, Jaipur.
