2. The Essential Qualifications prescribed should be recognised under IMCC Act 1970/ NCISM Act 2020.
3. Pay Band, Grade Pay (or Corresponding Pay Level and Pay Matrix) and NPA mentioned in the Essential Qualifications is applicable for all candidates equally irrespective of experience in Teaching or Research side.
4. The Caste/EWS Certificate should be in the manner and Form prescribed by the Central Govt. only. All such Certificates should be of the current year failing which the Application is liable to be rejected summarily.
5. The crucial date for determining the Age Limit for all Applicants will be the Closing Date for Receipt of Online Applications, i.e. 31-8-2023.
6. The Pay Scales in NIA carry usual Allowances admissible under Central Government Rules and applicable in the Institute.
