1. The bidder will visit the site (National Institute of Ayurveda, Jaipur) before submit the bid on working day during office hours with a prior intimation to the store officer, NIA, Jaipur on E-mail ID store-nia-rj@gov.in or mobile no. 9829437130 and obtain the mandatory site visit certificate from the Institute (NIA, Jaipur). The site visit certificate will be a part of the technical bid. In case the bidder fails to provide the site visit certificate along with the bid documents, his bid will not be considered.

2. The firms/companies/Agencies must have registered/Branch office in Jaipur. Documentary evidence of the same is to be submitted along with the bid. This will be a part of the technical bid. In case the bidder fails to provide the same along with the bid documents, his bid will not be considered.

3. The successful bidder will ensure cleanliness of all areas of the institute. All bathrooms and areas of the institute will be cleaned as per the terms and conditions of the tender and a checklist will be maintained, failing which a penalty of Rs. 2000 will be imposed per incident and in case of more than 3 incidents, the contract with the successful bidder can also be cancelled.
