

Subject:- Inclusion/ Recognition of PG (MD/MS) Ayurveda degree awarded by National Institute of Ayurveda (Deemed to be University), under Section 35 of the National Commission for Indian System of Medicine Act, 2020 - reg.

With reference to the subject mentioned above, I am directed to inform you that as per the erstwhile CCIM, the qualifications/degree are recognized/included under Second Schedule to the IMCC Act 1970. Now as the erstwhile CCIM has been repealed the degrees/qualifications included under schedule-II shall be maintained as it is and there shall not be any further additions/insertions/modifications. The newly formed NCISM act provides the provision of recognizing the qualifications/degrees under section 35. Hence a new system has been started and inclusion of qualification/degree shall be under section-35.
