Policy for implementation of Dynamic Assured Career Progression Scheme in the National Institutes (NIA, NIUM, NIH, NIS)

Dynamic Assured Career Progression Scheme (DACP) for the teaching faculties working in the National Institutes namely NIA, Jaipur, NIUM, Bangalore, NIS Chennai and NIH, Kolkata was implemented w.e.f 1st April, 2015 vide OM of even No. dated 6.6.2017 and 16.8.2017 with the concurrence of IFD/Deptt. of Expenditure. DACP Scheme ensures the benefits of both pay scale and designation in a time bound manner to the rank of Professor (SAG) level without linkage to vacancies. The benefits of promotion under DACP Scheme are as under:

2. All medical doctors (Ayurvedic, Unani, Siddha and Homoeopathy) whether belonging to organized services or holding isolated posts, will be covered by the DACP

Scheme. Essential qualification prescribed for the posts falling in purview of DACP Scheme shall be at least – Medical Degree in Ayurveda/Unani/Siddha/Homoeopathy System of medicine or MBBS/MD or their equivalent. As such criteria for eligibility for DACP shall be a medical degree possessed by the incumbent, Research publications etc., as per requirement of RRs amened from time to time. Tenure posts, posts filled on short term contract and deputation are excluded from the purview of the DACP Scheme. Further officers not having medical qualification are not eligible for promotion under DACP Scheme.

- 3. It has, however, been observed that after the implementation of DACP Scheme, various proposals have been received from these National Institutes for awarding regular promotion and DACP promotion separately to teaching faculities. Further, there are no specific guidelines for deciding the seniority issues of the incumbents getting DACP and those who are directly recruited at the level of Associate Professor/ Professor.
- 4. In order to sort out these issues and to ensure proper implementation of DACP Scheme, the following has been decided based on the recommendations of Committee of Directors of National Institutes (NIA, NIS, NIUM, NIH):
 - i) Since DACP promotion gives the benefits of both pay scale and post, the regular promotion is discontinued with immediate effect.
 - ii) The entry level post i.e. Lecturer (GP 5400) may be re-designated as Assistant Professor.
 - iii) The post of Assistant Professor as mentioned in order dated 6.6.2017 may be re-designated as Assistant Professor (Senior Scale).
 - iv) Consequent upon this, the promotion mechanism for the teaching faculities of these Institutes will be as follows:-

- v) Direct Recruitment(DR) at senior level is a way of bringing diverse talent to the Instituton. As such it has been decided that 50% regular posts of Associate Professor and Professor will be filled up on DR basis. These incumbents will subsequently avail the benefits of DACP scheme after completion of required years of service.
- vi) Remaining 50% posts of Associate Professor and Professor will be merged at entry level with Assistant Professor. Consequent upon the vacancies arising due to resignation/superannuation etc of the incumbents on these posts, it will be filled at the level of Assistant Professor.
- vii) Seniority issue among the teaching faculties in a Department should be resolved by adopting the criteria of 12 months, i.e. Direct Recruit (DR) teacher will be senior if appointed within the span of 12 months of DACP of a teacher on the same level. But if the DR teacher is appointed after the 12 months time, then the teacher promoted by DACP Promotion will be senior to the DR.
- viii) All other terms and conditions will remain the same as contained in OM of even number. dated 6.6.2017, 16.8.2017.
- ix) The Teaching Faculty will be recruited at the levels of Assistant Professor, Associate Professor and Professor. Therefore the faculties will be promoted under DACP in three different ladders as follows:

Explaination

- a) 50% regular posts of Associate Professor and Professor will be filled up on DR basis, which means,40 posts of Associate Professor and 20 posts of Professor will be filled up by DR basis. Thereafter, these incumbents will subsequently avail the benefits of DACP scheme after completion of required years of service. Any vacany arising due to resignation/superannuation etc of the incumbent at any level in Ladder II & III on these posts will be filled by DR only.
- Remaining 50% regular posts of Associate Professor (40 posts) and Professor (20 posts) will be merged with Assistant Professor (100 posts). Accordingly, 160 teaching posts will be filled up at the level of Assistant Professor only consequent upon vacancy arising due to resignation/superannuation etc at any level in Ladder-I. The incumbents will avail the benefits of DACP scheme after completion of required years of service.
- xi) The DACP is to be implemented in all the four National Institutes (National Institute of Ayurveda, National Institute of Unani Medicine, National Institute of Homoeopathy and National Institute of Siddha) alongwith designations
- xii) The regular promotion by holding DACP is dispensed with at all levels. The Recruitment Rules are to be formulated/revised accordingly.
- xiii) The existing provision of research experience prescribed for direct recruitment in Recruitment Rules will continue.
