4. All the above 3 institutions are requested to admit nominated Central Government Nominees (CGN) as per provisions of the CGN guidelines, 2024-25 quoted above in this regard. They may also ensure that no nominee/candidate is provided the subject which is available in their respective State/UT. Further, it is to inform you that the vacant seats in Central Pool under the Central Government Nomination Scheme for MD

(Ayurveda) for academic session 2024-25 shall be filled by Ayush Admission Central Counselling Committee (AACCC) of Ministry of Ayush as per the provision of the Scheme. Therefore, you are requested to inform the data of vacant seat to AACCC, Ministry of Ayush (aaccc-admn-ayush@gov.in) so that the vacant seat can be filled in time.
