Duly completed application are invited for the migration from other universities/institutes /colleges to National institute of Ayurveda, deemed to be University, Jaipur in 2<sup>nd</sup> Professional of BAMS course **(Admission Batch 2023-24)** after passing the 1<sup>st</sup> Professional of BAMS course from the Universities/Institutes/Govt./Private colleges duly recognized by the NCISM against the notified 18 vacant seats.

- The applicant must submit a No Objection Certificate (NOC) from the college attended for completing the 1st professional year of the BAMS course (Batch 2023-24), duly signed by the competent authority.
- Applicants must submit a separate No Objection Certificate (NOC) from the concerned university to which the respective government or private college is affiliated.
- College NOC and University NOC issued after the Application submission deadline will not be considered under any circumstances.
- No separate No Objection Certificate (NOC) will be required from the National Institute of Ayurveda, Deemed to be University, Jaipur, as this notification shall be treated as the NOC.
- Eligibility for migration will be strictly based on the All India Rank obtained in the NEET 2023 examination by candidates who have passed the 1st Professional year of the BAMS course (Batch 2023-24).
- Migration will be carried out in strict accordance with the prevailing reservation policy. If a suitable candidate is not available in a particular reserved category or among foreign nationals, the vacant seat will be treated as an Unreserved seat.
- If the number of applications exceeds the available vacant seats, then the merit will be decided as per the NEET All India Rank achieved NEET 2023 Examination.
- Applicant has to submit duly completed application along with the Migration Application fee of Rs. 5000 through online mode at [www.nia.nic.in](http://www.nia.nic.in) website.
- Selected candidate has to submit the Migration fee of Rs. 15000 along with the other applicable dues as per the prevailing fee structure.


- **How to apply**
