Revised Notification Regarding Ph.D. Interview Examination -2024

1. NIA Jaipur will conduct the interviews for Ph.D. selection on June 10th and 11th, 2024. Interviews are in Physical mode in the NIA Jaipur complex. On the same day (10 June 2024) ITRA Jamnagar will also be conducting interviews for the PhD selection.

Hence, to facilitate the common candidates (who have qualified for the NIA Jaipur test as well as are also appearing at ITRA Jamnagar for screening test or interview) and wish to attend interviews at NIA, the National Institute of Ayurveda, Jaipur, has decided to conduct the interviews through VC mode only for such candidates. However, this facility will be only on the request of such candidates through their mail to NIA Dean Ph.D. (dean_phd@nia.edu.in) with proof of candidature at Jamnagar (scanned copy of admit card or interview card). At the request of the candidate, a VC link will be shared with the candidate through her/his mail. This facility will be only for the candidates who are appearing at Jamnagar. All other candidates have to appear physically for the interview at NIA Jaipur.

2. The candidate shortlisted for interview shall present their interest and research proposal through a presentation (Duration 8-10 minutes) before a duly constituted University committee of the respective faculty.
3. All those candidates appearing in interview should also required to mention the name of the proposed guide from the list of registered supervisors provided in brochure of information.
4. In reserved category seats where candidates are either not available or not qualified will be filled by UR candidates except for OBC (PH) in Ayurved Samhita evam Siddhant subject.
