Sir/Madam,

1. To assess the available facilities of teaching, non-teaching, hospital staff, practical training and other infrastructure facilities at your college namely to **National Institute of Ayurveda, (Deemed to be University), Madhav Vilas Palace Amer Road, Jaipur-302002, Rajasthan (Inst. ID-AYU0225)** inspection was conducted on **15.04.2025 & 16.04.2025** in Hybrid mode as a part of annual visitation by the visitation team of Medical Assessment and Rating Board, NCISM to process the **Permission 100 seats (125 seats including EWS) in UG (BAMS) Course and 104 Seats (130 seats including EWS) in 14 PG Course** namely i) Agad Tantra avum Vidhi Vaidyaka- 06 seats (07 seats including EWS), ii) Prasuti & Stri Roga-07 seats (09 seats including EWS), iii) Dravyaguna Vigyana-09 seats (11 seats including EWS), iv) Kaumarbhritiya - Bala Roga- 07 seats (08 seats including EWS), v) Kayachikitsa-09 seats (11 seats including EWS), vi) Kriya Sharir-08 seats (10 seats including EWS), vii) Panchakarma-07 seats (08 seats including EWS), viii) Rasa Shastra & Bhaisajya Kalpana-08 seats (10 seats including EWS), ix) Rachna Sharir-07 seats (09 seats including EWS), x) Ayurved Samhita, Sanskrit & Siddanta-08 seats (10 seats including EWS), xi) Rog NidanavumVikriti Vigyan-08 seats (11 seats including EWS), xii) Swasthavritta-07 seats (09 seats including EWS), xiii) Shalakya Tantra-06 seats (08 seats including EWS) and xiv) Shalya Tantra-07 seats (09 seats including EWS) for the academic session 2025-26, under section 28 of NCISM Act, 2020.
2. Further, the visitation report and all other related documents were assessed in terms of the enforced regulations namely the Minimum essential standards, Assessment and Rating for Undergraduate and Postgraduate Ayurveda colleges and Attached Teaching Hospitals Regulations, 2024 and Minimum Essential Standards, Assessment and Rating for Postgraduate Institutions and Minimum Standards for Postgraduate Education in Ayurveda Regulations 2024", provisions under the NCISM Act, 2020 and relevant Regulations there under. **On careful examination of the assessment report it is found that your college is not fulfilling the notified & approved criteria, due to the following shortcoming:**

## 4. Mean of general and essential equipment's/instruments availability is 96.28%.

- Further, the Board had issued two letters to the college vide ref no. 3/2025/MARB/General Matters Dated 05.05.2025 and vide ref no. 3/2025/MARB/General Matters Dated 10.06.2025 with regard to bifurcation of Shalakya PG program into Shalakya-Netra Roga Chikitsa (Ayurveda Ophthalmology) & Shalakya-Karna, Naasa and Mukha Roga Chikitsa (Ayurveda Oto-Rhino-Larngology) as per sub regulation no. 3 of the Regulation 04 of MESA&R PG Ayurveda Regulation 2024, respectively to which the college had submitted their compliance.
- Further, the assessment report along with aforementioned compliance report was duly placed in the 128<sup>th</sup> Board meeting of Medical Assessment and Rating Board for Indian System of Medicine (NCISM) convened on 24.06.2025 and Board observed that the college is not fulfilling the notified & requisite criteria for issuance of permission as per the concerned acts and regulations, but is fulfilling the



criteria in accordance with the Board's policy letter issued on 09.01.2025 & 20.01.2025. Further, the Board also observed that the college is meeting the notified & requisite criteria for the issuance of the extended permission for 100 seats (125 seats including EWS) in UG as per regulation 54(2) of Minimum Essential Standards, Assessment and Rating for Undergraduate Ayurveda colleges 2024 and for 104 Seats (130 seats including EWS) in 15 PG Course as per Regulation 15(5) of NCISM (Minimum Essential Standards, Assessment and Rating for Postgraduate Institutions and Minimum Standards for Postgraduate Education in Ayurveda) Regulations 2024 as the college has been permitted for last three consecutive years with intake capacity of 100 seats (125 seats including EWS) in UG (BAMS) Course and 104 Seats (130 seats including EWS) in 15 PG Course. Accordingly, the Board decided as follows:

- a) To issue extended permission with 100 seats (125 seats including EWS) in UG (BAMS) course in accordance with Regulation 54 (2) of Minimum Essential Standards, Assessment and Rating for Undergraduate Ayurveda colleges 2024 under section 28 of NCISM Act, 2020, for the academic session 2025-26.
- b) To issue extended permission in PG with intake capacity 104 Seats (130 seats including EWS) in 15 PG Course namely i) Agad Tantra avum Vidhi Vaidyaka- 06 seats (07 seats including EWS), ii) Prasuti & Stri Roga-07 seats (09 seats including EWS), iii) Dravyaguna Vigyana-09 seats (11 seats including EWS), iv) Kaumarbhritiya - Bala Roga- 07 seats (08 seats including EWS), v) Kayachikitsa-09 seats (11 seats including EWS), vi) Kriya Sharir-08 seats (10 seats including EWS), vii) Panchakarma-07 seats (08 seats including EWS), viii) Rasa Shastra & Bhaisajya Kalpana-08 seats (10 seats including EWS), ix) Rachna Sharir-07 seats (09 seats including EWS), x) Ayurved Samhita, Sanskrit & Siddanta-08 seats (10 seats including EWS), xi) Rog NidanavumVikriti Vigyan-08 seats (11 seats including EWS), xii) Swasthavritta-07 seats (09 seats including EWS), xiii) Shalakyia Tantra-Netra Roga Chikitsa (Ayurveda Ophthalmology)-03 seats (04 seats including EWS), xiv) Shalakyia Tantra- Karna, Naasa and Mukha Roga Chikitsa (Ayurveda Oto-Rhini-Laryngology)-03 seats (04 seats including EWS) and xv) Shalya Tantra-07 seats (09 seats including EWS) in accordance with Regulation 15(5) of NCISM (Minimum Essential Standards, Assessment and Rating for Postgraduate Institutions and Minimum Standards for Postgraduate Education in Ayurveda) Regulations 2024, under section 28 of NCISM Act, 2020, for the academic session 2025-26.

5. Further, the same was communicated to you vide letter of even no. dated 05.07.2025. However, the bifurcation of Shalakyia Tantra PG course was not mentioned. Hence the decision is hereby being revised.

#### "DECISION"

6. Therefore, National Institute of Ayurveda, (Deemed to be University), Madhav Vilas Palace Amer Road, Jaipur-302002, Rajasthan (Inst. ID-AYU0225) is hereby granted with:-
  - a) Extended permission in UG (BAMS) course with intake capacity of 100 seats (125 seats including EWS) in UG (BAMS) for the academic session 2025-26 in accordance with Regulation 54 (2) of Minimum Essential Standards, Assessment and Rating for Undergraduate Ayurveda colleges 2024 and;
  - b) Extended permission in 06 PG courses with intake capacity of 104 Seats (130 seats including EWS) in 15 PG Course namely i) Agad Tantra avum Vidhi Vaidyaka- 06 seats (07 seats including EWS), ii) Prasuti & Stri Roga-07 seats (09 seats including EWS), iii) Dravyaguna Vigyana-09 seats (11 seats including EWS), iv) Kaumarbhritiya - Bala Roga- 07 seats (08 seats including EWS), v) Kayachikitsa-09 seats (11 seats including EWS), vi) Kriya Sharir-08 seats (10 seats including EWS), vii) Panchakarma-07 seats (08 seats including EWS), viii) Rasa Shastra & Bhaisajya Kalpana-08 seats (10 seats including EWS), ix) Rachna Sharir-07 seats (09 seats including EWS), x) Ayurved Samhita, Sanskrit & Siddanta-08 seats (10 seats including EWS), xi) Rog NidanavumVikriti Vigyan-08 seats (11 seats including EWS), xii) Swasthavritta-07 seats (09 seats including EWS), xiii) Shalakyia Tantra- Netra Roga Chikitsa (Ayurveda Ophthalmology)-03 seats (04 seats including EWS), xiv) Shalakyia Tantra- Karna, Naasa and Mukha Roga Chikitsa (Ayurveda Oto-Rhini-Laryngology)-03 seats (04 seats including EWS) and xv) Shalya Tantra-07 seats (09 seats including EWS) for the academic session 2025-26 in accordance with Regulation 15(5) of NCISM (Minimum Essential Standards, Assessment and Rating for Postgraduate Institutions and Minimum Standards for Postgraduate Education in Ayurveda) Regulation, 2024;
7. The aforementioned decision is issued under section 28 of NCISM Act, 2020 subject to the condition that following requirements shall be fulfilled:-
  - i) It is further informed that **100% of undergraduate seats** of the permitted intake capacity **with 125 seats (including EWS)** Shall be treated as all India quota and with reference letter no. F.1/(340/PG/ACA/2021-2022 dated 08.11.2021 the matter related to **130 PG seats (including EWS)** was placed before NCISM in its meeting held on 16.11.2021 and it was decided by the Commission that National Institute of Ayurveda comes under the De-Novo category which is different than the deemed to be university category as per UGC norms/regulation. Hence NCISM allowed the existing seat matrix and quota for 130 PG seats (including EWS) for the admission in National Institute of Ayurveda, (Deemed to be University), Jaipur, Rajasthan. **The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government/NCISM for all India quota or the students admitted thereunder.**
  - ii) It is also informed that determination of fee and all other charges in respect of 50% of seats in private Medical Institutions and deemed to be University should be as per the guidelines issued by NCISM vide ref



no. BUSS/Fee/ASU/2022-23 dated 16.09.2022. Fees of the remaining 50% of seats are to be fixed as per the guidelines of Fee Fixation/Regulatory Committee (FRC) of respective State/UT/Deemed to be University.

8. Admissions made in violation of the above conditions will be treated as invalid and action will be initiated under NCISM Act & Regulations thereunder.
9. Further, as per Sub-section (7) of Section 29 of NCISM Act, 2020, The Medical Assessment and Rating Board for Indian System of Medicine may conduct evaluation and assessment of any University or medical institution at any time, either directly or through any other expert, having integrity and experience in medical profession, without any prior notice and assess and evaluate the performance, standards and benchmarks of such University or medical institution and if the college is found to be not maintaining the Minimum Essential standards as specified in the concerned Acts & Regulations then in accordance of Section 28 (1) (f) of NCISM Act, 2020 the issued permission of the college shall deemed to be withdrawn and denial of permission shall be issued by MARBISM for stoppage of admission for that particular academic year or the subsequent year.
10. Discrepancies, if any, may be immediately brought to the notice of Medical Assessment and Rating Board for Indian System of Medicine, NCISM.
11. The following requirements should be fulfilled by the college as per Regulation 55 (2) of MESAR 2024 and 15(a) (b) of PG MESAR 2024 and the compliance report shall be submitted before 31<sup>st</sup> December, 2025 to be considered for the permission for the academic session 2026-2027:-
  - i) All the requirements under the provisions of the NCISM Act, 2020 and relevant Regulations made thereunder should be fulfilled.
  - ii) All the requirements of Minimum Standard of infrastructure and teaching & training facilities as specified in NCISM (Minimum essential standards, assessment and rating for undergraduate Ayurveda colleges and attached teaching hospitals) Regulations, 2024.
  - iii) All the requirements of Minimum Standard of infrastructure and teaching & training facilities as specified in NCISM (Minimum Essential Standards, Assessment and Rating for Postgraduate Institutions and Minimum Standards for Postgraduate Education in Ayurveda) Regulations, 2024.
  - iv) All the requirement of the National Commission for Indian System of Medicine (Minimum Standard of Undergraduate Ayurveda Education ) Regulations, 2022
  - v) The compliance of shortcoming mentioned in para- 02.
  - vi) Compliance of all the requirements of Aadhaar Enabled Biometric Attendance System as mentioned in the Implementation letters vide. ref. no. 3/2024/MARB/AEBAS & HMS. Dated 09.05.2024 & 06.09.2024 issued by the Board.
12. The fulfillment of the conditions given above may be made within the time period specified and compliance report should be submitted by the college within the timeline as mentioned above to the President, Medical Assessment and Rating Board for Indian System of Medicine. The Medical Assessment and Rating Board for Indian System of Medicine will verify that the conditions have been fulfilled for considering the permission for the academic session 2026-27.
13. The letter issued vide letter of even no. dated 05.07.2025 hereby stands null & void.
