Finance Committee felt that that it is justified to create Posts for the increased academic and related activities of Deemed University as the Institute has to undertake various work and programs of a University on in its own and it is not possible to manage the work with limited Teachers, Officers and Staff by entrusting such additional duties and responsibilities to them.

Finance Committee noted that the Institute has to operate its Central Laboratory for Patient Investigations and Research Activities on its own after termination of the PPP Model.

#### Agenda Item No. 8

To consider and recommend Procurement of Equipments, Instruments, Articles for Development of Departments, etc. at an Estimate Cost of Rs. 678 Lakhs.

Finance Committee reiterated that all the procurements approved in a financial year should be completed within that financial year itself. It was also stressed that all proposals for procurement of Equipments, Machineries, Instruments etc. should be placed before the Finance Committee in the 1st Quarter of the Financial Year so that the procurements can be completed within that financial year. Finance Committee recommended, in principle, Procurements of the following Equipments, Instruments, Articles etc. for Development of various Departments, Laboratories, Drug Testing Laboratory, Pharmacy, Central Laboratory etc. All the Procurements

should be made through GeM and following codal formalities.




