(b) With regard to Minutes in respect of Agenda No. 18, it may be mentioned in the Minutes that "the agenda was taken up for discussion and representative of IFD stated the proposal of remuneration to officers assigned with additional responsibilities of Deemed University may not be considered by Finance Committee as it is NIA, Jaipur submitted the justification for this not empowered to approve such remuneration. proposal. Representative of IFD then stated that views of Department of Expenditure, Ministry of Finance could be obtained on this proposal. Thereafter, In view of justification provided in the agenda and submitted during the discussion, Finance Committee, recommended, in principle, the proposal to grant fixed monthly remuneration to teachers and officers of NIA, Jaipur, assigned with additional responsibilities, for carrying out the activities of Deemed University smoothly, till regular required posts are created, subject to concurrence of IFD. Finance Committee further advised NIA, Jaipur to submit the proposal on file to Ministry of AYUSH, giving all relevant details, for further examination."

The Administrative Officer and Finance Officer I/C NIA welcomed the Chairman Members and all participants in the Meeting and requested the Chairman for his opening remarks.

The Chairman, in his opening remarks, cordially welcomed all the Members. He requested all the Members to recommend the proposals after due consideration and deliberations. He hoped that this Meeting will be successful and will definitely pave the way to the Deemed University for further development and enrichment of activities. Thereafter, with the permission of the Chairman, Agenda Items were presented.

Agenda Item No. 1

To confirm Minutes of the 1st Meeting of Finance Committee held on 5-3-2021.

Finance Committee confirmed the Minutes of its $1^{\rm st}$ Meeting held on 5-3-2021.

Agenda Item No. 2

To report Action Taken/Present Position on the Recommendations of Minutes of 1st Meeting of Finance Committee held on 5-3-2021.

Finance Committee noted the Action Taken/Present Position on the Recommendations of the 1st Meeting. The Action Taken/Present position in respect of Item No. 3.3 should be reported in Review Committee of the Ministry. The action taken/present position should be reported in detail with each and every step taken by the Institute like date of tender for PMC, name of PMC finalized, tender floated, award of work, amount deposited etc. Finance Committee is also of the opinion that Institute's own capacity should be developed in respect of minor electric and civil works. All procurement should be completed in the current financial year itself. So far as point No. 3.8 is concerned, Finance Committee advised that valuable obsolete items should not be underestimated and proper procedure must be followed.

Agenda Item No. 3

To consider and recommend Grant of Stipend of Rs. 25,000 Per Month to Scholars to be admitted in the new PG Courses. (Rs. 36 Lakhs Per Annum)

Finance Committee **recommended** to grant a Stipend of Rs. 25,000 Per Month to the Scholars to be admitted in the 6 new PG Courses with an intake capacity of 2 Seats each, subject to IFD concurrence. A proposal along with comparative statement mentioning stipend of equivalent courses presently being paid by other organization for such types of courses should be submitted to the Ministry for obtaining IFD concurrence. The Committee felt that it is mandatory to run these 6 new PG Courses for maintaining status of Deemed-to-be-University of the Institute to comply with the condition mentioned in Letter of Intent.

To consider and recommend various Constructions, Repair, Renovation Works etc. for Strengthening Infrastructure for various Activities (Rs. 7261 Lakhs)

Finance Committee felt that the Items should be categorized in new works, revised works etc. Each work should separately be explained with clear-cut description of Finance Committee approval, Budget, Agency and present status etc. The proposals were discussed in detailed and **recommended** as under:

1. Construction of Hospital Building in the newly acquired Land at Malviya Nagar(Basement+Ground+7 Floors) - Rs. 3000 Lakhs and

2. Construction for VC Residence(Basement+Duplex) & Multi-Storey Type-IV Quarters (Basement+Ground+7 Floors) - Rs. 1132 Lakhs.

These proposals may be kept on hold for the present.

3. Construction of 2nd Floor and Addition & Alteration of Hospital Building - (Rs. 927 Lakhs) and

Finance Committee **recommended** the Proposal for Construction of 2nd Flood and Additional & Alteration of Hospital Building at an estimated Cost of Rs. 927 Lakhs subject to clearance of authorities/local bodies.

4. Construction of 2nd Floor on existing Admn. Building (Rs. 467 Lakhs).

Finance Committee **recommended** the Proposal for Construction of 2nd Floor on the existing Old Administrative Building at an estimated Cost of Rs. 467 Lakhs subject to clearance of authorities/local bodies.

5. Construction of Boundary Wall and Allied Works of Herbal Garden (Rs. 316 Lakhs).

Finance Committee **recommended** the Proposal for Construction of Boundary Wall and Allied Works of Herbal Garden at an estimated Rs. 316 Lakhs.

6. Laying of Water Supply Line for various Buildings - Rs. 88 Lakhs.

Finance Committee **recommended** the Proposal for Laying of Water Supply Line to various buildings at an estimated Cost of Rs. 88 Lakhs.

7. Construction of Lift-Well and Installation of Capsule Lift Academic Block - Rs. 54 Lakhs.

The Proposal was discussed in detail. It was noted that NIA has engaged NPCC as PMC for construction work costing Rs. 21 Crores. The work of construction of Lift-Well and Installation of Capsule Lift was mentioned in the scope of work given to PMC. Therefore, Finance Committee felt that no fresh approval is necessary. This work should be completed on urgency basis.

8. Repair & Renovation of Dissection Hall - Rs. 27 Lakhs.

Finance Committee **recommended** the Proposal for Repair & Renovation of Dissection Hall at an estimated Cost of Rs. 27 Lakhs.

9. Aluminium Partition of Halls and Rooms - Rs. 20 Lakhs.

Finance Committee **recommended** the Proposal for Aluminium Partition of Halls and Rooms at an estimated cost of Rs. 20 Lakhs.



10. Construction, Addition and Alteration of 1st Floor of Panchakarma Building - Revised Cost: Rs. 1230 Lakhs:

Finance Officer I/C informed that a construction project for construction of 2 floors on the existing Panchakama building was approved by SFC costing Rs. 2100 Crores in its 55th Meeting held on 6-3-2019. Keeping in view urgency of work it was decided to construct only 1st Floor on Panchakarma building instead of 2 Floors and work order for Rs. 1039 Lakhs was given to NPCC.

The other works costing Rs. 1061 lakhs (2100-1039) having urgent nature, were allotted to NPCC on priority basis instead of Construction of 2nd Floor on the existing building of Panchakarma. These works were essential keeping in view the safety measures of the entire building, space requirement for newly launched Departments, providing facilities to patients and staff, manufacturing medicines in Pharmacy, sufficient lights in the Campus in night hours etc. The other works allotted to NPCC are: Installation of Fire protection/Detection/Alarm and Fire Fighting System in various building, Repair and Renovation of Existing Toilet and construction of OPD & IPD in Hospital and Admn. Building, Repair and renovation of Committee Hall and Committee Room, Repair and Renovation of 6 Electric Furnaces for Pharmacy, Construction of Badminton Court for Students, Construction for 1st & 2nd Floors on the existing Guest House and Warden Quarter, Construction of 3 Halls in front of Swastha Vritta and Installation of High Mast Lights.

Due to site condition, requirements and suitability of facilities the additional works like installation of Fire-Fighting Equipments, Provision for UPVC, Windows with Grills, Renovation of Toilets and Kitchen of Ground Floor on ground, etc. were awarded to NPC for which PMC submitted an Revised estimated of Rs. 1230 against which an amount of Rs. 1039 Lakhs have already been paid to PMC and therefore, the enhanced estimated cost of Rs. 190 Lakhs is submitted for approval before the Committee.

The Proposal was discussed in detail and Finance Committee **recommended** the additional construction work of 1st Floor of Panchakarma Building at the Revised Cost Estimate of Rs. 1230 Lakhs.
