#### Clause 13 (VI)

Only In-service candidates shall be having option to get stipend from the Institute or draw salary from their respective parent department. The mention of sponsored candidates requires to be removed.

### Ph. D Ordinance

Clause 03.3.1b In case of candidate cease to be a regular employee of the university then his/her candidature may be cancel Suggested change: If the candidate wishes to

continue his/her Ph.D. then it should be mandatory for the candidate to be with the guide for a stipulated period.

It was also discussed and approved to fix the number of pages of thesis upto maximum 200 pages. In case If a candidate finds it insufficient for his/her thesis he/she can apply separately to the Vice chancellor to increase the pages of his/her thesis and should get permission for the same

Clause 19.1.1 External examiner should be holding a Ph.D. degree and having minimum Qualification of Associate Professor.

Suggested change: Ph.D. degree shall not for mandatory the qualification as external examiner. In place of it, it shall be mentioned as External examiner preferably a Ph.D. degree holder with minimal status of the Associate Professor." Clause 22.1 The viva-voce examination, based among other aspects, on the critiques given in the evaluation report, shall be conducted by the Research Supervisor and at least one of the two external examiners.

Suggested change: In place of at least one of the two examiners, it shall be written as either of the two external examiners. If the examiner rejects a second examiner shall be invited for viva voce.

Clause 26.3. Teaching assistantship provided
