After detailed discussions it was recommended that In personal regular meetings of concerned authorities from NIA and the concerned authorities from Academy of Scientific & Innovative Research (ASIR) .The Chairman Academic council informed the Academic council that a meeting has already been scheduled for Dec. 6th 2023 with NIA authorities and concerned authorities from Academy of Scientific & Innovative Research (ASIR) in regards to the practical & hassle-free implementation of the MoU done between NIA Jaipur (ASIR) with proper planning for its execution, sensitization and dissemination of the detailed outline of the cotutelle programme.
2. Academic council also recommended the provision of research grant of 20 lakhs per project for the Dual Ph.D. Programme with the provision of further enhancement after the due permissions from the appropriate authorities.
